NOTICE OF INTRODUCTION

NOTICE IS HEREBY GIVEN that the foregoing ordinance was introduced and passed by the Township Committee on first reading at a meeting of the Township Committee of the Township of Tabernacle held on the 14th day of March 2016. The purpose of this Ordinance is to amend restrictions on parking at Town Hall Municipal Building to be exclusively used by persons conducting Township business and not available to Tabernacle Township Municipal Court patrons during normal business hours. **This ordinance will be further considered for final passage at the next meeting of the Township Committee on April 25, 2016 at 7:30 P.M.** and held at the Municipal Building, 163 Carranza Road, Tabernacle New Jersey 08088. ORDINANCE 2016-1

AN ORDINANCE OF THE TOWNSHIP OF TABERNACLE, COUNTY OF
BURLINGTON, STATE OF NEW JERSEY, AMENDING AND
SUPPLEMENTING CHAPTER 7, "TRAFFIC" ADDING SECTION 7-9
ENTITLED "RESTRICTIONS ON PARKING AT TOWN HALL
BUILDING"

WHEREAS, the Township Committee of the Township of Tabernacle is authorized by the provisions of *N.J.S.A. 39:4-197*, to enact ordinances regulating the parking of vehicles upon land owned or leased and maintained by the municipality, including the designation of certain parking spaces; and

WHEREAS; the Town Hall building has seen a recent increase in vehicular parking; and

WHEREAS; the Township Committee wishes to ensure that Township residents conducting business at Town Hall have access to and the availability of designated parking spaces.

NOW, THEREFORE, BE IT ORDAINED By the Committee of the Township of Tabernacle, County of Burlington, State of New Jersey as follows:

Section 1:

Chapter VII Traffic, Section 7-9 of the Revised General Ordinances of Tabernacle Township is hereby amended to add the following section:

7-9 Restrictions on parking at Town Hall building

In accordance with the provisions of *N.J.S.A. 39:4-197*, the Township of Tabernacle shall designate (2) two parking spaces at the Tabernacle Township Town Hall and (1) one parking space at the Annex for use by persons who are conducting official Township business at the Town Hall and the Annex during regular business hours. Such spaces are to be exclusively used by persons conducting Township business and not available to Tabernacle Township Municipal Court patrons during normal business hours.

Section 2: All other Ordinances or parts of Ordinances inconsistent with the provisions of this Ordinance are hereby repealed to the extent of such inconsistency.

Section 3: If any section, subsection, clause or phrase of this ordinance is held to be unconstitutional or invalid for any reason, such decision shall not affect the remaining portions of this ordinance.

Section 4: This ordinance shall be in full force and effect from and after its adoption and any publication as may be required by law.

ORDINANCE 2016-2
CALENDAR YEAR 2016
ORDINANCE TO EXCEED THE MUNICIPAL BUDGET APPROPRIATION LIMITS
AND TO ESTABLISH A CAP BANK
(N.J.S.A. 40A: 4-45.14)

WHEREAS, the Local Government Cap Law, N.J.S. 40A: 4-45.1 et seq., provides that in the preparation of its annual budget, a municipality shall limit any increase in said budget up to 0% unless authorized by ordinance to increase it to 3.5% over the previous year's final appropriations, subject to certain exceptions; and

WHEREAS, N.J.S.A. 40A: 4-45.15a provides that a municipality may, when authorized by ordinance, appropriate the difference between the amount of its actual final appropriation and the 3.5% percentage rate as an exception to its final appropriations in either of the next two succeeding years; and

WHEREAS, the (Township Committee) of the Township of **Tabernacle** in the County of **Burlington** finds it advisable and necessary to increase its CY 2016 budget by up to 3.5% over the previous year's final appropriations, in the interest of promoting the health, safety and welfare of the citizens; and

WHEREAS, the Township Committee hereby determines that a 3.5 % increase in the budget for said year, amounting to \$ **113,926.54** in excess of the increase in final appropriations otherwise permitted by the Local Government Cap Law, is advisable and necessary; and

WHEREAS the Township Committee hereby determines that any amount authorized hereinabove that is not appropriated as part of the final budget shall be retained as an exception to final appropriation in either of the next two succeeding years.

NOW THEREFORE BE IT ORDAINED, by the Township Committee of the **Township of Tabernacle**, in the County of **Burlington**, a majority of the full authorized membership of this governing body affirmatively concurring, that, in the CY 2016 budget year, the final appropriations of the Township of Tabernacle shall, in accordance with this ordinance and N.J.S.A. 40A: 4-45.14, be increased by 3.5%, amounting to **\$113,926.54**, and that the CY 2016 municipal budget for the **Township of Tabernacle** be approved and adopted in accordance with this ordinance; and

BE IT FURTHER ORDAINED, that any that any amount authorized hereinabove that is not appropriated as part of the final budget shall be retained as an exception to final appropriation in either of the next two succeeding years; and

BE IT FURTHER ORDAINED, that a certified copy of this ordinance as introduced be filed with the Director of the Division of Local Government Services within 5 days of introduction; and

BE IT FURTHER ORDAINED, that a certified copy of this ordinance upon adoption, with the recorded vote included thereon, be filed with said Director within 5 days after such adoption.

WHEREAS, the Township Committee recognizes a compelling public safety interest in regulating the excavation of roads within the Township of Tabernacle; and

WHEREAS, N.J.S.A. 40:48-2. *Other necessary and proper ordinances*, provides that any municipality may make, amend, repeal and enforce such ordinances, as it may deem necessary and proper for the good government, order and protection of persons and property, and for the preservation of the public health, safety and welfare of the municipality and its inhabitants;

NOW, THEREFORE, BE IT ORDAINED By the Committee of the Township of Tabernacle, County of Burlington, State of New Jersey as follows:

Section 1:

Chapter XII Streets and Sanitation, Section 12-1 of the Revised General Ordinances of Tabernacle Township is hereby amended to add the following section:

12-1.11 Permits not to be Issued on Streets Improved within Five (5) Years

a. No permit shall be issued to any person which would allow an excavation or opening in a street surface which was paved or improved less than five (5) years prior to the date of the application, unless the applicant can clearly demonstrate that public health or safety requires that the proposed work be permitted, or unless the applicant is a public utility seeking to permit the expansion of utility infrastructure or unless an emergency condition exists. For streets that have been resurfaced or reconstructed within five (5) years of the date of the street opening, the seams of the surface pavement repair shall be blended with the existing pavement surface utilizing an infrared pavement restoration process.

Section 2: All other Ordinances or parts of Ordinances inconsistent with the provisions of this Ordinance are hereby repealed to the extent of such inconsistency.

Section 3: If any section, subsection, clause or phrase of this ordinance is held to be unconstitutional or invalid for any reason, such decision shall not affect the remaining portions of this ordinance.

Along with this notification, homeowners will be asked to notify the contractor of any items of concern that relate to their property (underground private structures such as sprinklers, property markers, septic and wells, etc.) along with landscaped areas.
7. SJG Contractor will attempt to meet with residents during the construction project to address concerns they might have.
8. SJG contractor will videotape area where pipeline is to be installed prior to construction start for documentation purposes.
9. Proposed pipeline will be installed by a combination of bore, plow and open-cut methods. Bore and plow are the preferred means of construction, but when open cutting of trenches occurs during construction of the project, the contractor will make every effort to keep disturbance to a minimum.
10. SJG contractor will restore all areas disturbed to same conditions and all non-vegetated areas must be reseeded.
11. All Township roads and paved driveways must use bore method of installation.
