APPLICATION FOR THE USE OF RECREATION FIELDS AND FACILITIES BY TOWNSHIP GROUPS AND ORGANIZATIONS FOR RECREATIONAL PURPOSES

It is the policy of Tabernacle Township to make its Recreation fields and facilities available to all township groups and organizations of Tabernacle Township on a priority basis. Non-township organizations will be scheduled around Township groups and organization. A security deposit will be required for non-township groups and organizations: \$300 for a single event, \$600 for 3 day event and \$1,000 for more than 3 days or league. Proof of a 51% residency requirement must be provided to be considered a township organization.

All scheduling must be approved by Recreation Committee or its designee. All recreation field rules must be followed.

TO ALL APPLICANTS:

This application must be in the office of the Township Administrator, 163 Carranza Road, Tabernacle, New Jersey 08088, at least one month before the date of the event.

You will be notified of the approval or disapproval of the use of the buildings within five days after the scheduled Township meeting.

REQUIREMENTS

General Liability:

- A. Commercial general liability with a \$1,000,000.00 combined single limit of liability for bodily injury and property damage including blanket contractual, premises and products liability.
 - B. Private coverage to be primary.
 - C. Township to be named "additional insured"; and
 - D. User must execute a hold harmless agreement (included)
 - E. Sports associations must show evidence that their general liability policy will respond to injuries sustained by athletic participants, or show a certificate of insurance evidencing an athletic participants medical payments policy.
1. Be subject to Ordinance 2001-9 (See copy attached).

The applicant by the signature below affirms that it has read all of the rules and regulations pertaining to the use of the Recreation Fields and Facilities subject to all of the regulations imposed. The applicant will complete the "statement of waiver claim" and return the statement with the applications.

INDEMNITY AND HOLD HARMLESS AGREEMENT

_____, agrees to indemnify and hold harmless the Township of Tabernacle, its officers, employees, volunteers, and agents, from and against all claims, damages, losses, and expenses, including reasonable attorney's fees in case it shall be necessary to file an action, arising out of performance of the work herein, which is:

This indemnification and agreement shall apply in all instances whether the Township of Tabernacle, its officers, employees, volunteers, and/or agents, is/are made a party to the action or claim or a subsequently made a party to the action by third-party in-pleading or made a party to a collateral action arising, in whole or in part, from any of the issues emanating from the original cause of action or claim.
